BUSINESS LICENSE AND REGISTRATION

- All food businesses must hold a food business license with the City of Minneapolis or Minnesota Department of Agriculture (MDA), and list NEON Collective Kitchens.
- All businesses must be registered entities and share proof of registration.

BUSINESS INSURANCE

- All food businesses must hold a current food liability policy and name NEON Collective Kitchens as a certificate holder on their policy.
- If you already have a policy, this shouldn't cost you anything - just ask your insurance agent.

FOOD MANAGER CERTIFICATION

- All food businesses must have a Minnesota Certified Protected Food Manager (MCPFM) present for all kitchen use.
- Certification must be provided to the kitchen prior to use.
